#### 3. Laboratory Course in Microbiology 401.

Professor N. E. R. Campbell emphasized the need of a laboratory course in Microbiology 401 and observed that in view of the large number of students demanding space it is difficult to plan a <u>full</u> laboratory course. He made the following proposal:

"That the Science Committee give approval to a plan by the Microbiology Department to institute periodic laboratory demonstrations in Microbiology 401 in lieu of one of the three lectures per week."

Professor Neamtan seconded.

Professor A. N. Campbell, while not objecting to the proposal, remarked that the regulation requires 3 lectures plus one laboratory/week.

The chairman said that he had seen Dean Sibley regarding this matter and reported that Dean Sibley would be happier if the Science Committee approved this.

4. Discussion of the Science Curriculum in the New General Course.

The chairman invited new ideas on this subject which could be put forward as a report to the following Faculty Council meeting.

Following some discussion the motion -

"that the Committee accepts the whole Dulmage plan as it is" - (moved by Prof. A. N. Campbell and seconded by Prof. Mendelsohn) was carried by 11 to 4 voltes. 5. Motion. Moved by Prof. N.E.R. Campbell and seconded by Prof. I.Cooke

"To facilitate pedestriat movement by Academic staff and Graduate students to an from the nexus of Science Buildings and the Main Library, a tunnel or covered walkway be constructed from the Buller Building to the Main Library."

Prof. Connor reminded the Committee that the total sum of money available to the University was finite and that if so expensive an undertaking as this were to be commenced, other projects would have to suffer.

Prof. Whitmore supported Prof. Connor and expressed that other things have higher priority and the cost benefit for a tunnel would be disproportionate.

The Motion was defeated.

(a) A Motion by Professor Gothern: This arose out of the discussion of item 5 - the tunnel between Buller Bldg. and Main Library. "That the chairman of the scienc committee storid contact the Librarian to investigate the jossibility of moving the science foods and the private to the science Annex to the Main Library would be somewhat lessened if the Science books were kept in the Science Complex. Prof. Cooke, while also seconding the motion, said that this was discussed once before in the Science Committee meeting when the Librarian was present.

The Motion was passed.

(b) Prof. A. N. Campbell said that the was pleased to see the appointment of the Associate Dean of Science and wondered if in a future meeting we might not discuss the areas in which the Science Committee and the Dean of Science might be expected to have an autonomy in deciding "desiderata" for Science courses and in the running of the Science Departments.
