Dean Losey explained that this special meeting of Faculty Council was called as a result of a request from the Science Library User's Committee to Dean Bigelow. Dean Bigelow agreed that a special meeting of Faculty Executive and Faculty Council should be called to discuss the library problems.

Dean Losey asked Prof. R. Lyric, Chair of the Science Library User's Committee, to give the reasons for this request. Prof. Lyric went into the history of the library difficulties.

This was followed by a lengthy discussion on the problems of the library. -The reduction in serials is a serious problem not only for Science but the whole system.

- -It's impossible to get new serials in library.
- -Problem of priorities in University--libraries not being given first priority.
- -We must protect the serials.
- -Perhaps amalgamation of smaller libraries.
- -Cut the library hours and move study space out of the library.

Dr. Duckworth requested that before meeting breaks up that a method of preparing a list of books that could be cut be agreed on. This was taken as a suggestion to the Science Library User's Committee.

The following motion of the Science Library User's Committee was placed before Faculty Council by Prof. Lyric.

"The Faculty Council of Science wishes to draw to the attention of the senior administration the critical state within the University of Manitoba Library system.

- 1. The Faculty Council believes that any "Drive for Excellence" must begin with a philosophical recognition that an adequate library is a fundamental requirement for the maintenance of high standards of instruction and research.
- 2. That in view of the urgency of the current situation the President of the University of Manitoba should take immediate steps to present a report to Senate on the state of the libraries with respect to financing, and with particular regard to the effects of budgetary shortfalls on teaching and research at the University of Manitoba.
- 3. That the President, if unable to correct the current critical situation unilaterally, should pursue the matter with the Board of Governors and if need be with the Provincial Government.
- 4. The council affirms that the present mechanism for serials cancellation cannot be continued. Any future cancellations must take into account institutional priorities to minimize the long-term disruptive effects on teaching and research programs at the university."

A lengthy discussion followed.



The Faculty of Science Library User's Committee unamimously requests that an emergency meeting of the Faculty Council of Science be called at the earliest time, to discuss the very serious implications of impending serial cuts in the library system, with particular regard to the quality of education in the Faculty of Science and in the University.

A SUGGESTED SOLUTION FOR THE LIBRARY AND EQUIPMENT PROBLEMS

- 1. There is no question that the University is suffering from a desperate shortfall in miscellaneous capital and in monies for general capital. The Library is one place where much more capital is needed for the purchase of books and journals. The professional faculties are desperately in need of monies to maintain current equipment and to buy new equipment.
- 2. It is equally clear, and has been over the past several years, that the Government is not in a position at this time to provide monies to keep up the capital expenditure on library books and equipment that is absolutely essential for the proper functioning of a good University.
- 3. Tuition fees are quite low at Manitoba in relation to many other institutions, but there is a very understandable desire not to raise tuition unduly. This is quite similar to the desire of Federal and Provincial Governments not to raise taxes.
- 4. I think that we might well consider what the Federal and Provincial Governments do when they are in desperate need of extra funds, but do not wish to raise taxes. They introduce a **Temporary Library/Equipment Surtax**, which is brought in as a temporary measure to solve immediate problems.
- 5. We propose that a Temporary Library/Equipment Surtax be levied on tuition, over and above the regular tuition, this would involve a levy on every student registered at the University in the amount of \$300.00 per student per full academic year. This would raise an appreciable amount of money on a temporary basis, and this money could go into a special fund which would only be used for library book renewal and for equipment renewal.
- 6. This is a drastic proposal, but it has the advantage of focusing attention on a very desperate problem. It also has the advantage of being a temporary measure. It has also the advantage of being easily understood by both the general public and Federal and Provincial Governments, since it is the sort of measure that has been used many times by both Federal and Provincial Governments.
- 7. It is hoped that this would be only a temporary measure. It should obviously occur each year until the Province is in a situation where it can provide capital monies for the library and for equipment.
- 8. Indeed, while the government may not wish to provide direct funds for capital expenditure on library books and on equipment, it might find that it was desirable to provide these funds indirectly in the following way. The Government might give, to each university student, an extra bursary in the amount of \$300.00, this extra bursary to be used to pay the surtax levy levied upon each student.
- 9. In conclusion, one can express the hope that this measure would only be in effect until such time as the Government was itself able to take steps to remedy the lack of library books and journals and the lack of equipment. No one likes additional charges, but the University situation is so desperate that the traditional "surtax" method of raising extra funds, a method employed many times by our Federal and Provincial Governments, seems to be the only reasonable approach.
