5. The Chairman informed Council that the Faculty's Course Change proposals had been approved by the Executive Committee and would now be forwarded to the Senate Curriculum and Course Change Committee for consideration.

6. Academic Regulations: The Chairman advised Council that the Faculty Student Standing Committee and the Executive Committee had approved deletion of a clause "All cases involving failed courses shall be referred to Student Standing" from the regulations regarding continuation in the 4-Year Major program. It was felt that there was no need for this clause as, unless a student has failed more than 18 credit hours in the program, he/she is eligible to proceed, and the 18 hour stipulation is monitored by the Dean's Office at each point of assessment. As this is a "housekeeping" matter the Chairman presented it to Council for information. After a query regarding the fact that some departments in the initial stages of the program had wished to withdraw students after 2 failures, and assurances by Dean Losey that no such requests had been received thus far, the Council accepted the revision with no objections.

7. As the Executive Committee reporter was unable to be present, the Chairman noted that a report would be made at next Faculty Council.
8. Dr. McKee reported on various matters that had been or were about to be considered in Senate including the powers of the Senate Appeals Committee; the SPPC Space Report and the proposed inter-faculty program in Genetics.

There being no further business, the meeting adjourned at 3:09 p.m.

DR. GEORGE LUBINSKY

George Lubinsky, Professor Emeritus in the Zoology Department, age 74, died suddenly on the morning of 7 September 1981. George was actively involved in teaching and research at the University for 21 years. He commanded international respect as a parasitologist.

He was born on 28 January 1907 in Kiev, Ukraine. In 1930 he graduated from the Faculty of Medicine at Kiev University with the degree of M.B.B.S. In 1940 he received the degree of Candidate of Biological Science from Kiev University. Dr. Lubinsky came to Canada in 1954 as a research associate at the Institute of Parasitology at McGill University and received his Ph.D. in 1956. He was granted Canadian citizenship in 1959 and came to the University of Manitoba in 1960. From then to his retirement in 1974 he was most active in teaching and research in parasitology. After his retirement he was named Professor Emeritus and continued his research until the present. Over 60 publications arose from his research written in five languages. Eleven students received postgraduate degrees under his supervision. He was a member of St. Andrew's College and its Senate and was a member of the Ukrainian Academy of Arts and Science in Canada. His outside interests were diverse, ranging from the origin of man through to art and astronomy.

His counsel and encyclopedian knowledge was utilized extensively by both students and staff. His total dedication to teaching and to the pursuit of knowledge at the University served as a source of inspiration to all who knew him. We shall miss his charm, his keen sense of humor, and his scholarship.
